Purpose: (One Case)

<u>Appeal #617</u> – Ohio Roll Grinding Inc. of 5165 Louisville St. NE, Louisville, Ohio 44641, zoned I-2 General Industrial, Parcel #33-07849, is requesting a variance for a setback of 20 feet on the west of the existing building and proposed addition, instead of the required 25 feet minimum side yard width in Section 722.4, item C of the Nimishillen Township Zoning Resolution.

CALL HEARING TO ORDER:

Chairman Aslanides opened tonight's hearing at 7:00 PM and introduced all board members in attendance and the zoning inspector. Chairman Aslanides swore in everyone in attendance by asking them to swear that the information they were about to present, either in oral or written form, is true and accurate to the best of their knowledge. The people responded by stating, "I do".

CALL HEARING TO ORDER:

<u>Appeal #617</u> – Ohio Roll Grinding Inc. of 5165 Louisville St. NE, Louisville, Ohio 44641, zoned I-2 General Industrial, Parcel #33-07849, is requesting a variance for a setback of 20 feet on the west of the existing building and proposed addition, instead of the required 25 feet minimum side yard width in Section 722.4, item C of the Nimishillen Township Zoning Resolution.

<u>Bill Jeffries of 5274 Woodview</u> stepped to the podium and notified the Board that he was in attendance for the owner who could not attend the hearing. Bill Ehlers asked if this new building will be big enough. Mr. Jeffries stated that 4,000 square feet is all that is needed at this point.
