7:00 PM – Special Meeting:

On Monday, May 7, 2018, the Board of Trustees of Nimishillen Township held a special meeting for the purpose of interviewing for the Full Time Road Worker Position at 7:00 PM at the Nimishillen Township Hall located at 4422 Maplegrove NE with the following members present: Trustee President Todd D. Bosley, Trustee Vice President George P. Kiko, and Trustee Jennifer L. Leone.
